Meeting Minutes Board of Directors – Regular Meeting November 18, 2021 - 10:00 a.m.

Call to Order: Ann Arritola called the meeting to order at 10:10 a.m. Members present; Ricky Keller, Jerry Preston, and Jeff Okamoto. Members absent; None. **District Employee**: Reed Campbell and Ellie Davis. **Visitors**: None.

Approval of Minutes:

a. Regular Meeting Minutes of October 21, 2021 were approved.

Approval of Bills:

a. Ann made a motion to pay the bills for October 2021 as presented. Ricky seconded the motion, the motion carried unanimously.

Accounting Reports:

a. Profit & Loss and Balance Sheets were reviewed.

Operator Report:

- This month we have run into a problem with our transfer pump to Section 25 at full capacity. We will continue to track down the issue. With winter around the corner and our irrigation season over for the year, we have started winterizing Section 25 and other portions of our system. Replacing our main line valve indicator poles have also been underway, and we may look into alternative materials to use. The conditions, other than being colder, the system is running smooth. Nothing at this time proves to show otherwise.
- Last month the district received the new Chlorine Injection Pump for the Section 25 irrigation system. Pump Tech will send out a sales rep closer to spring to help set it up and get it running. With winter setting in soon, we will start clearing fence lines and doing some road maintenance on the Section 25 property. Will do some fire reduction as well when we are clearing fences. I purchased new hoodies, t-shirts, and hats. They have big bold lettering on them so our customers will know who we are for sure, without any question.
- Ethan was unsuccessful with his level one testing with DEQ. He will continue to study and apply to retake the test again later.

Old Business:

- a. New Board Member Jeff reached out to Mac, and he has decided to withdraw his interest in the open position. Elreta had a prior commitment and is unable to be at today's meeting. However, she is still interested in the open position. Ann made a motion to swear Elreta Humeston at the December board meeting for the vacant position #5. Ricky seconded the motion, the motion passed unanimously.
- b. <u>COVID-19 Exposure/Quarantine</u> The Board discussed options for employees, considering the pandemic is ongoing. They feel it would be best to address this in a case-by-case basis.
